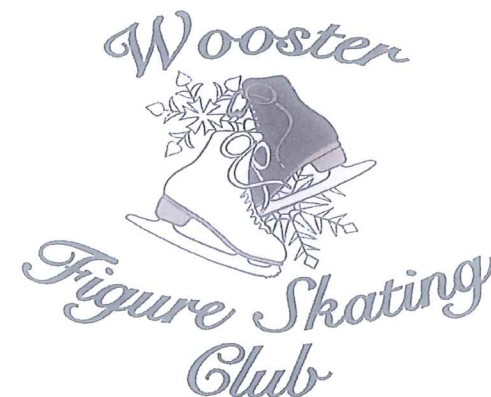
TERMS AND CONDITIONS

- (1) I hereby understand that if contracting ice, it is done through the Wooster Figure Skating Club for the period designated.
- (2) All contracts, punch cards and walk-on fees are due and payable in advance of using the ice.
- (3) A \$25 processing fee will be assessed for checks returned for insufficient funds.
- (4) Club Ice times and dates are subject to change based on ANIA programming needs. Contracted ice time will be rescheduled to make up lost sessions or refunds will be awarded as determined by the WFSC Board
- (5) In the event that I wish to cancel any part or all of the contracted ice, I must petition the board in writing to the attention of the Club secretary, ten days prior to the desired cancellation date. Failure to petition the board will result in the contract remaining in effect and all dues and late fees are still owed to the club.
- (6) If a refund is granted by Board approval, a pro-rated refund (less 15% administration fee) will be issued.
- (7) If an ice session reaches maximum capacity, priority is given to skaters in the following manner:
 - First.....Contracted Skaters
 - Second.....Club punch cards
 - Third.....Club walk-on
 - Fourth.....Non-Club punch card
 - Fifth.....Non-Club Walk-on
- (8) Club Ice capacity is set at 22 skaters or an amount determined by the Monitor based on conditions at the time.
- (9) It is the responsibility of each skater to check in with the ice monitor before taking the ice to skate. This includes the second session each day if you are skating on the first. You may indicate to the monitor that you will be skating both sessions if intending to do so. If you have not committed to the second session when checking in during the first session you must leave the ice and re-check with the monitor. Failing to do so may result in the skater being asked to come off the ice.
- (10) Contracted Skaters and punch card holders **Will NOT** be given credit for unused sessions at the end of the season.
- (11) If a skater is unable to make a contracted session, they may attend any future session using one of their pre-allotted vouchers. These vouchers are not free sessions, They are to be used to make up missed session only. The number of vouchers depends on the number of hours contracted for ice.
- (12) A completed club membership packet must be turned in and the membership fee must be paid in order to contract for WFSC ice time.
