Winter Show

The Winter Show will take place on Sunday December 7th 2008. The show will comprise of a Holiday recital put together by the participants and their coaches. A show committee will be put together to help coordinate this event. Jeff Stump is the Chairperson for this group.

The Learn To Skate Program (LTS) will run a class specifically for LTS patrons who want to be in the show. Participants in this program will be included in the recital as part of several group numbers put together by the Wooster Skating Academy staff.

Participants in this class will receive training in show etiquette and also learn valuable performance training as well as actually getting to perform in the Winter Recital 2008.

Members of the WFSC will be able to contract directly with a coach of their choice to help with choreography of their performance. Ice time and coach time will be paid for by each individual or group of skaters and they will be responsible for their own costumes.

There will be a \$20 charge to Noble Kids and Club Members for being in the show. There will be **no** charge for the LTS kids over and above the fee they have paid to participate in the performance class.

Club Members may sign up for either a duet/small group number **or** a solo. Time limits for individual/small group numbers will correspond with the time level they would adhere to if they were competing in a free-skate competition.

Bob Lapsley will be making contact with various synchronized skating teams to determine if any are able to accept an invitation to be guest skaters at the Recital.

These Show specifics were motioned by Joel Kennedy, Seconded by Bob Lapsley and agreed upon with a majority vote of the members present.
